Introduction

We take the protection and security of your personal data seriously. This Privacy Policy outlines our privacy practices regarding how we collect, use, and protect your personal information in our interactions with you online, over the phone, via text/SMS/chat, and when you visit our co-working spaces. We encourage you to review this Privacy Policy regularly as we may update it from time to time. All changes will be effective upon posting on this page, unless otherwise specified.

Compliance with PIPEDA

We comply with all applicable Canadian privacy laws, including the Personal Information Protection and Electronic Documents Act (PIPEDA) and the Canadian Anti-Spam Legislation (CASL). This means we obtain your consent for the collection, use, and disclosure of personal information and follow all rules and regulations established by Canadian federal, provincial, and municipal governments. We respect your privacy rights and are committed to safeguarding your personal data.

Our Websites & Digital Services

This Privacy Policy applies to all websites, domains, and digital services owned by ElastaLink Corp. and @Hive (collectively, the "Websites").

Our Websites may link to third-party websites for your convenience. However, we do not control their privacy practices, and this Privacy Policy does not apply to any personal data shared with those third parties. We encourage you to review the privacy policies of any external sites you visit.

Collection and Use of Personal Information

When you interact with us, whether by visiting our Websites, registering as a member, completing surveys, joining a mailing list, or purchasing products/services, we may collect personal information such as:

- **Contact Information:** Name, address, telephone number, email address, unique login details (username and password).
- **Demographic Information:** Type and size of business, location, etc., to provide a personalized experience.
- **Professional Information:** Occupation, company name, and industry.
- **Financial Information:** Credit card details, billing/shipping addresses for payment processing (used solely for billing and fraud prevention).
- **Technical Information:** Browser type, operating system, IP address, and usage data collected automatically to diagnose problems, analyze trends, and improve the Websites.

If you call us, we may collect personal data during the conversation, and calls may be recorded for training and quality purposes. You will be notified at the start of the call if recording is taking place, with the option to opt-out by ending the call.

Directories, Forums, and Message Boards

On our Websites, we may provide directories, forums, and/or message boards to our members. The

information in these areas is available only to our members; however, you should exercise caution when deciding to disclose personal information in these spaces. While we strive to maintain a secure environment, we cannot guarantee the security of any information disclosed online within the members' community. Any information you choose to share in these areas is disclosed at your own risk.

To access the members' community, you will be provided with a username and password. Please do not share your username and password with anyone. If you forget your login details, follow the provided instructions to reset them or contact us at contact@athive.com for assistance.

Cookies and Other Digital Tags

We use cookies and similar technologies to track and improve your experience on the Websites. Cookies help us remember your preferences and optimize processes, such as when booking office space or making purchases. You can disable cookies via your browser settings, though doing so may limit your ability to access certain features of our Websites. Children's Privacy

We do not sell personal information. However, we may share your data with third-party service providers to facilitate the delivery of products and services you have requested. These third parties are contractually bound to protect your information in accordance with data protection legislation.

We may also share personal data internally between ElastaLink Corp and @Hive for consolidated reporting, storage, and streamlined customer information management.

Security of Your Information

We take reasonable precautions to protect your personal information. While no online data transmission is entirely secure, we adhere to industry standards to safeguard your data, including encryption using Secure Socket Layer (SSL) technology for sensitive information such as credit card details.

We retain personal data for a period determined by the nature of the information and its purpose. For

example, we retain data related to contracts and services for six years after your last interaction with us. Marketing data is retained until you withdraw consent or opt out of communications, after which your preferences will be updated in our systems.

Business Transitions

In the event of a business transition, such as a merger, acquisition, or sale of assets, your personal information may be transferred as part of the transaction. We will notify you if such a transition affects your data.

What Are Cookies?
